STAKE HOLDERS WORKSHOP

Stakeholder Consultation workshop for preparation of City Development Plan of Udaipur was held on 14 July 2006 at Udaipur Chamber of Commerce Industries, Madri Industrial Area, Udaipur. The daylong workshop commenced at 11 am in morning and concluded in evening by 3.00 pm.

The purpose of workshop was to seek consensus on a variety of issues that would go into preparation of City Development Plan such as vision for city and priorities for development. Stakeholders occupying highest rung of decision-making attended the workshop to discuss project related issues on a common platform. A wide array of stakeholders was invited for workshop ranging from elected representatives of people, urban administrative departments, urban local body, Udaipur Municipal Council (UMC), development authorities such as Udaipur improvement Trust (UIT), academicians, Non governmental organizations, traders, etc. A total of 30 participants attended the workshop. WORKSHOP PROCEEDINGS: TECHNICAL SESSION 1

Mr. Shikhar Agarwal, IAS, District Collector, Udaipur

The workshop was thrown open by District Collector, Udaipur. He focused on the importance for capacity building of various government assets, need for proper restructuring of community development centers. He felt that urban poor needs to be benefited through all these assets. He called for stringent guidelines for monitoring and implementation of various projects in alignment with the planned guidelines.

Brief on UIDSSMT by CEO of PDCOR, Mr. Paritosh Gupta

Mr. Gupta explained and highlighted the mandate of Urban Infrastructure Development Scheme for Small and Medium Towns (UIDSSMT). He outlined the funding schedule under UIDSSMT, the budget, and use of private public partnerships in the project.

Mr. Gupta began his presentation by introducing the team for CDP Udaipur & identified various agencies and urban local bodies involved in the project. He briefly mentioned about

infrastructure development sectors permissible under UIDSSMT highlighting some key sectors permissible under UIDSSMT such as urban renewal, Water supply and drainage, Sewerage and sanitation, heritage conservation etc.

The CEO stressed upon need for preparation of CDP to qualify for funding under UIDSSMT and, outlined the proposed framework for preparation of CDP for Udaipur.



WORKSHOP PROCEEDINGS: SESSION 2

Presentation on 'State of the City' City Development Plan - Udaipur (Prof. H.M. Shivanand Swamy, Team Leader, CDP Udaipur)

Prof. H.M. Shivanand Swamy presented the key report on city development plan. While stressing upon the unique identity of Udaipur,



he also established the need and purpose of workshop to arrive at a consensus on vision for the city and priorities for future development.

Prof. Swamy identified the structure of presentation: sections on: Demography and Economy, Urban Growth management, Housing, Kachhi Bastis and slums, urban services, Heritage and conservation, institutional arrangements and urban finance were discussed in detail by team leader, Prof. Swamy, highlighting the existing scenario for Udaipur.

Beginning with historic significance of Udaipur city, constituent areas of city, Prof. Swamy discussed about city growth and other demographic characteristics such as population etc. He also identified the economic base and other economic activities sustaining the city before proceeding to urban growth management of Udaipur and ongoing new projects in the city.

Prof. Swamy, then went on to establish key characteristics of housing, stock, demand etc for the city and baseline scenario of *kacchi bastis* in the city. During section on urban services, he pointed out in detail the existing situation, future demands and related issues for all urban services such as water supply, sewerage, storm water drainage, SWM, traffic and transportation and heritage and conservation aspects.

On the aspect of institutional arrangements, Prof. Swamy began with identification of the city institutions involved in planning, implementation and operation and maintenance. He detailed out the structure and related institutional issues of all concerned agencies. He concluded the presentation with existing state of finances of agencies. The Team Leader then explained the methodology to be adopted.
